Arrival and Unloading

Gates open at **7:30 am**. Please plan to arrive **before 9:30 am**. Please follow the signs to your unloading area.

No vehicles will be allowed in after 10:00am. Please be kind to your neighbors and move your vehicle as quickly as possible. Volunteers will be onsite to help you unload, if needed.

All vehicles must be moved from the event site by 10:00 am.

At the end of the day: For the safety of our attendees, **no vehicles are allowed in the event area until 4:15pm.**

Finding Your Station – Checking In

Please check in at the *Winery Check-in Tent* to receive your wristband and glass. A volunteer will come to your pouring station to confirm your location. All persons within the event must have a wristband – *no exceptions.*

Each winery is pre-assigned a location.

Pouring at the Event

Please bring at least **two cases** of each wine being poured (0.5 oz. metered pourers are recommended). No sales of wine allowed at the event. Wineries must comply with all federal and state rules and regulations. Wines must be labeled as Barbera.

Each winery will be provided with:

- Two event wine glasses and handstamps for two representatives to attend and enjoy the event. Additional persons must purchase event tickets in advance. **(Use your winery code for a \$10 discount—contact us for your code.)**
- A shaded 8' table with table covering. *Two wineries will share an 8' table.*
- Pour bucket; water pitcher
- One chair per winery; 2 chairs per table.
- If the day is exceptionally warm, ice will be provided as needed. Ice buckets are not provided.

If you need special accommodation, please contact us in advance. We will do our best to accommodate all reasonable requests. We will be unable to make changes the day of the event.
