Join us for the 10th Annual Barbera Festival!

Thank you for participating in the 10th annual Barbera Festival! Projected attendance is around 1,800, which includes all attendees, winery personnel, volunteers, media, and special guests.

Application and Fee due **August 20th**

To participate, the following forms must be received no later than August 20th. Participation is limited to 4 Vendor Tents, for a total of 28 spaces.

Fee is \$100, payable to the Amador Vintners Association (see Application for payment details). Vendors retain 100% of sales and are responsible for all taxes and fees.

Each Vendor Receives: Each vendor in the tent area is provided with a 10' x 10' space under a 20' x 40' or 20' x 20' structured tent, 6' table, 2 chairs (unless otherwise noted that these are not needed), admittance for you and one helper (if requested), and free parking. Please bring a covering for your table.

There is no Wireless available at the Winery so please consider this in regards to using Square or other Wireless Payment systems. AT&T wireless hot spot seems to be the most reliable source of internet currently.

To participate, please fill out and return:

- BOE Form (no fee)
- Vendor Application and \$100 fee
- **FOOD PRODUCTS:** Amador County requires all vendors selling an edible product to:
 - Submit a Temporary Food Facility form (on website).
 - Check "**Other**" and write in "*Annual Temp Event Permit*"
 - The TFF will be dated Jan 2021 - Dec 2021 and is valid for *all events* for that year
 - A fee of \$60 per event or \$120 for all events within a calendar year is required, payable to *County of Amador*
 - Send the form and payment to Amador County Environmental Health Department, 810 Court Street, Jackson, Ca. 95642

Arrival and Unloading

Gates open at **7:30 am**. Please plan to arrive **before 9:30am**. Please follow the signs to your unloading and parking area.

No vehicles will be allowed in after 10:00am. Please be kind to your neighbors and move your vehicle as quickly as possible. Volunteers will be onsite to help you unload, if needed.

All vehicles must be moved by 10:00am.

Finding Your Location – Checking In: Each vendor is preassigned a location in one of the 4 Vendor Tents. A volunteer will be onsite to confirm your location, check you in, and provide you with a wristband. All persons within the event must have a wristband – *no exceptions*.

At the end of the day: For the safety of our attendees, **no vehicles are allowed in the event area until 4:15pm.**
